CHAMBER OF ADVISORS

Order of the president of the Chamber of Advisors dated 5 April 2010, opening an external competitive examination on the basis of tests for the recruitment of principal engineers.

PRIME MINISTRY

Decree n° 2010-835 dated 30 April 2010, granting an exceptional leave to the public agents candidates to the 9th May 2010 elections.

The President of the Republic,

On a proposal from the Prime Minister,

Having regard to law n° 83-112 dated 12 December 1983, relating to general status of the personnel of the State, local collectivities and public establishments with administrative nature, all amending and completing texts and notably law n° 2007-69 dated 27 December 2007,

Having regard to law n° 85-78 dated 5 August 1985, relating to general status of the agents of the offices, public establishments with commercial and industrial nature and companies whose capital is held directly and entirely by the State and the local collectivities, all amending and completing texts and notably law n° 2007-69 dated 27 December 2007,

Having regard to decree n° 2010-104 dated 26 January 2010, convening the electoral body for the election of the members of the municipal councils,

Having regard to the opinion of the Administrative Tribunal.

Decreases the following :

Article one - Is granted, for the election campaign provided for by the decree referred to above n° 2010-104 dated 26 January 2010, an exceptional leave with full salary to the public agents candidates to the 9th May 2010 elections, and this, from 2 to 7 May 2010.

Art. 2. - Shall profit from this leave, the candidates having the quality of:

- agents of the state, or local collectivities or public establishments with administrative nature,

- agents of the public enterprises and establishments.

Art. 3 - The leave granted, on the basis of the provisions of the decree herein, are not taken into consideration in the calculation of the duration of the rest leaves granted to these agents in accordance with the legislation in force.

Art. 4 - The Prime Minister, the Ministers and the Secretaries of State, each in his respective capacity, shall implement the decree herein which shall be published in the Official Gazette of the Republic of Tunisia.
